The Grand Jury charges:

Count One

Possession of an Unregistered Firearm (Violation of 26 U.S.C. §§ 5861(d), 5871)

On or about November 27, 2017, in the Abilene Division of the Northern District of Texas, and elsewhere, **John Devin Diaz**, defendant, knowingly possessed a firearm, as that term is defined in 26 U.S.C. § 5845, that was, and could readily have been put in, operating condition, that is, a destructive device commonly known as a pipe bomb, not registered to him in the National Firearms Registration and Transfer Record, defendant knowing the characteristics of said firearm.

In violation of Title 26, United States Code, Sections 5861(d), 5871.
